Rossendale Books Terms & Conditions

1st November 2013

These terms & conditions form the legal basis for the contract between *Rossendale Books* and individual authors. 'We', 'us' and 'our' in the points below refers to 'Rossendale Books'.

GENERAL NOTES

a) Payments

Can be either by PayPal or Cheque or Postal Order or Direct Bank Transfer.

b) Starter Fee for our Printed Book Package

There is a non-returnable starter fee of 50% (or other amount by arrangement) of the paperback or hardback publishing package price which, when received by *Rossendale Books*, starts the publishing process for your book.

c) Starter Fee for eBook Package on its own

There is a non-returnable starter fee of 100% of the total eBook publishing package price which, when received by *Rossendale Books*, starts the publishing process for your eBook. This applies where the author decides to publish an eBook only.

d) Starter Fee for our Printed Book Package along with our eBook Package

There is a non-returnable starter fee of 50% (or other amount by arrangement) of the paperback or hardback publishing package price and eBook package price which, when received by *Rossendale Books*, starts the publishing process for your book.

e) Agreement on Fees

We will not expect you to pay a starter fee until we have sent you by email an exact cost breakdown of our charges: you will know, right from the start, what you are committing to in terms of fees.

f) Balances Due

Once you receive the first copy of your book the final balance becomes payable - except where the eBooks package has been purchased on its own and already paid for in full as in **c)** above. This final balance will include the Book Design and any other fees - but minus the starter fee. We will send an invoice to you by email advising you on the final balance.

g) Publishing Rights: Printed Books & eBooks

Rossendale Books will not hold any publishing rights to an author's book, whether it is a printed book or eBook: this means the author is free to find another publisher for their book with no penalty fees or charges for moving to another publisher. They are also free to use the source documents (book interior and cover design) to arrange their own reprinting of copies.

h) Printed Books: Draft Cover Design - Electronic Version

We will request advice from you on the cover design in terms of the title, 'blurb' for the back cover, a photograph of the author (optional) and a description of the author – 'bio'. We will send a draft cover by email for your approval.

i) Printed Books: Draft Book Interior - Electronic Version

As well as sending you the draft cover design by email for your approval we will also send you the draft design of the main body of your book ('the book interior') by email for approval. Read it carefully and note down any mistakes or changes which you wish to make.

Please Note: we do correct an author's work, but only when authorised by the author.

Ownership of the text is at all times the responsibility of the author. The draft book interior electronic version allows the author (or ourselves on behalf of the author) to make any last-minute changes before the first copy of the book is printed.

j) Maximum Number of Revisions BEFORE PUBLICATION

Five (5) is the maximum number of revisions to the cover design or the book interior to be carried out free of charge as part of the overall package price. This number is usually more than adequate to allow the book interior and the cover design to be at an acceptable state for publication. *Where an author continues to make revisions or corrections or changes to either the book interior or the cover design past this maximum number of revisions, an additional charge of £35.00 will be incurred for each revision thereafter.*

k) Changes to Printed Books or eBooks AFTER PUBLICATION

If the author wishes to make changes to the main text in the printed book or to the cover or to the text in eBooks after publication, they must inform us by email. A minimum charge of £35.00 is payable for a republication of your book, whether the changes are to the cover or to the main body of text or to the eBook text, with the charges scaled as below:

- £35.00 for up to 10 changes
- £50.00 for 11 to 25 changes
- £75.00 for 26 to 50 changes
- By agreement for more than 50 changes

l) Copyright

Rossendale Books has no interest in owning the copyright to your book and this remains with the author at all times. Inside your book, we will insert a page at the front of the book with details similar to those below.

m) First Book Copy: Printed Books Only

We arrange for a first printed copy (or other copies by arrangement) of your paperback or hardback book to be sent to the address which you specify - this is described as *the complimentary copy* on our website and in our email messages to authors. *Note that for revisions and updated versions of a paperback or hardback book, the author must pay for any further print orders of the updated book through the ordering process on their storefront.*

n) Corrections

It is important to stress to all of our authors that we are not novelists ourselves nor are we poets or playwrights or biblical scholars or technical authors and so we cannot take responsibility for the main body of your book's text – the ownership of this text, as the copyright states, rightly belongs to you as the author. If you do want to get someone to look at your text word-by-word and line-by-line, the services of a proof reader are required - see clause *o)* below.

o) Proof Reading: Printed Books & eBooks

If you wish to use our proof reading services, please ask. [There is a separate charge of £1.85 per thousand words for this service.](#) Please note that the proofreader can not guarantee to have captured every single mistake in a manuscript, although in most cases they will do so. Where mistakes have been found in a text which has been proofread and the book has subsequently been published, **Rosendale Books** hereby undertakes to carry out a revision to correct any mistakes free of charge and provide a further complimentary copy of the book.

p) Scanning of Images, Documents & Photographs

As part of our standard package we will scan images, documents and photographs for use in an author's book up to a maximum of forty (40) scans. The author must supply appropriate captions for each scan. [For scans greater than forty, an additional charge will be applied as agreed with the author.](#) Note that, as part of this service, the author must post the items to us by registered post and we will, after completion of the scanning, return the items to the author by registered post.

q) Images supplies by the author

Where an author supplies us by email or CD with an electronic version of images, photographs or documents to use in their book, as part of our standard package we will accept a maximum of forty (40) such items. [For items greater than forty, an additional charge will be applied as agreed with the author.](#)

r) The Contract Between Rosendale Books & Its Authors

Once an author has made a starter fee payment and sent a copy of their manuscript:

1. We undertake to provide cover design services, book interior design services, ISBN and a storefront for showcasing any printed books and/or eBooks.
2. We will not proceed to publication until the author gives us an approval for both book interior and cover design - this means that updated book and cover designs are sent by us to the author in different versions (v1, v2, v3 and so on) until the author is fully satisfied with both the book interior and cover design. There is no extra charge for this updating service (up to a maximum of five versions, see clause *j)* above) and it is a standard part of our self-publishing package.
3. We will add images, documents and photographs to their book, if appropriate, as described in clauses *p)* and *q)* above.
4. We undertake hereby that we will not apply any exclusive terms or conditions on the publication of an author's book or eBook - this means that the author is free, after our publication of their book, to republish their work elsewhere without any hindrance by us and with no financial penalty or charge by us.
5. We confirm that there are no 'hidden' charges over and beyond whatever is stated in our emails to an author or in any fee or invoice documents attached to emails and also what is stated in these Terms & Conditions.

6. We confirm that we have no interest in obtaining a share in the sales or royalties from sales of the author's printed books or eBooks.
7. We confirm that the author is the holder of the copyright to the text which forms their work (and images or illustrations, if included as part of the publication and the author has rightful claim to those illustrations or images).
8. We confirm that copyright for the cover design, if supplied by us, and the book interior design (but not the text itself or any images as in point 7. above) are assigned from us to the author on receipt by us of the final due payment from the author.
9. Please note that **until all the final monies owed to us are paid by the author, copyright to the cover design, if supplied by us, and the book interior design (but not the text itself or any images as in point 7. above) belongs to *Rosendale Books*.**
